ENVIRONMENTAL POLICY

- Creating an environmentally friendly working environment by developing and mainstreaming a sense of social responsibility for the protection of the environment, and raising environmental awareness, including for all our stakeholders, subcontractors and suppliers,
- Supporting and developing the work of NGOs and local governments to ensure the continuity of natural resources and the protection of biodiversity,
- Choosing and continuously developing environmentally sensitive technologies in order to minimize the environmental impacts that may arise from our activities and carrying out R&D studies in this context,
- Using natural resources efficiently in line with sustainable development goals,
- Continuously developing and improving all stages of our activities by analyzing their environmental impact and dimensions,
- Assessing the impacts of all planned investments and projects on biodiversity and ecosystems, and developing plans to mitigate their impacts during construction/implementation, operation and post-operation,
- Incorporating environmental risks and opportunities into our decision-making processes,
- Reducing the water and carbon footprint of all our activities,
- Implementing the Zero Waste Management System in our activities,
- Taking international water-related standards, widely adopted initiatives and local initiatives as guidance,



• Ensuring that the wastewater we produce is treated/disposed of in accordance with the legislation where the local infrastructure in the areas where we carry out our activities is inadequate.

Objective of the Policy

This policy aims to set out on guiding activities to provide an environmentally friendly working environment for all our internal and external stakeholders and society.

Scope of the Policy

This policy covers all our stakeholders, including our employees, subcontractors, suppliers, visitors, local communities.

Implementation of the Policy and Relevant Legislation

In this context, all relevant regulations, particularly the Environmental Law, will be implemented first. In case of any incompatibility between the applicable legislation and this policy, IC Holding accepts that the applicable legislation will prevail.

This policy is reviewed periodically and updated when deemed necessary. Directorate of Management Systems is responsible for updating the policy. The policy entered into force on October 24, 2022 upon the approval of the Board of Directors.
